- Double Booth (20x10) for both days- \$100
- Singe Booth (10x10) for one day- \$30
- Electricity for Both Days \$15.00

Returning vendors may request to have the same booth location, however, it is not guaranteed.

#### Set-up/ Take-down:

Vendors will be able to set up starting on Friday, September 21, 2018 from 10am until 4pm. Vendors will be located inside our greenhouse, which will be locked overnight. We ask that all vendors be removed by Monday, September 24<sup>th</sup> at 2pm. A map included in the information packet will depict the location of vendor drop-off and parking. - 1. Exhibitors must abide by the requirements as set forth in this application. Those exhibitors who do not display items depicted in the images submitted may be asked to leave. The Garden Factory shall not be liable for lost profits or consequential or incidental damages including, but not limited to: travel, lodging, insurance or wages.
- 2. All exhibitors must be registered with the State of New York and display Certificate of Authority and New York State Tax Identification number at all times during the festival. Artists are responsible for collection and payment of 8% local sales tax- 4% on clothing under \$110.00. If your registration is pending you may write "pending" on this application but must submit a New York State Tax ID number prior to the festival date. For information regarding a New York State Tax Certificate, contact the NY State Tax Department at (800) 972-1233 or <u>www.state.ny.us</u>
- 3. The Garden Factory is not responsible for any damage, loss of personal property, personal injury or accidents involving exhibitors and their personnel. Exhibitors must agree to hold The Garden Factory harmless from any and all claims, liabilities, demands, lawsuits, costs, penalties, expenses (including reasonable attorney fees) and judgments due to breach of this agreement by exhibitors or their personnel.
- 4. Your submission of the application indicates that you agree and will comply with the rules and regulations stated herein.

### EXHIBITOR CONTRACT

- 1. <u>ALL items must be handcrafted</u> by booth applicants or members of their family. Direct sales **will not** be accepted. Additionally, exhibitors must offer the arts/crafts represented in their application photographs.
- 2. Single exhibit spaces are 10x10. Exhibitors must confine their displays and materials to their assigned and allotted space.
- 3. No booth fee refunds will be given after your application has been accepted.
- 4. Any application without photographs will not be given consideration.
- 5. Incomplete applications will not be given consideration.
- 6. All exhibitors are responsible for collecting and reporting New York State Sales Tax. A copy of your New York State Certificate of Authority must be displayed in your exhibit.
