Required:

- At least 1 photograph of booth display and 4 photographs of work submitted with the application
- Valid Certificate of Authority
- Valid NY State Sales Tax Id. Number

Booth Fee:

- Single Booth (10x10) for both days - \$50
- Double Booth (20x10) for both days- \$100
- Single Booth (10x10) for one day- \$30

Returning vendors may request to have the same booth location, however, it is not guaranteed.

Checks made out to The Garden Factory may be dropped off to our customer service desk or mailed to The Garden Factory Attn: Nicky Martell 2126 Buffalo Road Rochester, NY 14624. All payment must be received by the start of the festival, Saturday, September 23rd, 2017.

Set-up/ Take-down:

Vendors will be able to set up starting on Friday, September 22nd, 2017 from 10am-4pm. Vendors will be located inside our green house, which will be locked overnight. We ask that all vendors be removed by Monday, September 25th, 2017 at 2pm. A map included in the information packet will depict the location of vendor drop-off and parking. Information packets will be available after acceptance.

RULES/REGULATIONS:
FESTIVAL TERMS

1. Exhibitors must abide by the requirements as set forth in this application. Those exhibitors who do not display items depicted in the images submitted may be asked to leave. The Garden Factory shall not be liable for lost profits or consequential or incidental damages including, but not limited to: travel, lodging, insurance or wages.
2. All exhibitors must be registered with the State of New York and display Certificate of Authority and New York State Tax Identification number at all times during the festival. Artists are responsible for collection and payment of 8% local sales tax- 4% on clothing under \$110.00. If your registration is pending you may write "pending" on this application but must submit a New York State Tax ID number prior to the festival date. For information regarding a New York State Tax Certificate, contact the NY State Tax Department at (800) 972-1233 or www.state.ny.us
3. The Garden Factory is not responsible for any damage, loss of personal property, personal injury or accidents involving exhibitors and their personnel. Exhibitors must agree to hold The Garden Factory harmless from any and all claims, liabilities, demands, lawsuits, costs, penalties, expenses (including reasonable attorney fees) and judgments due to breach of this agreement by exhibitors or their personnel.
4. Your submission of the application indicates that you agree and will comply with the rules and regulations stated herein.

EXHIBITOR CONTRACT

1. **ALL items must be handcrafted** by booth applicants or members of their family. Direct sales **will not** be accepted. Additionally, exhibitors must offer the arts/crafts represented in their application photographs.
2. Single exhibit spaces are 10x10. Exhibitors must confine their displays and materials to their assigned and allotted space.
3. No booth fee refunds will be given after your application has been accepted.
4. Any application without photographs will not be given consideration.
5. Incomplete applications will not be given consideration.
6. All exhibitors are responsible for collecting and reporting New York State Sales Tax. A copy of your New York State Certificate of Authority must be displayed in your exhibit.
